I declare that I hold a current CERTIFICATE OF INSURANCE, with, in particular, third party liability insurance to the value of £3 million. The organisers shall not be liable for any loss, damage, death or personal injury howsoever caused to the owner, his skipper or crew as a result of their taking part in the event. Moreover, every owner warrants the suitability of his yacht for the event.

The safety of the yacht and her entire management, including insurance, shall be the sole responsibility of the owner/competitor who must ensure that the yacht is fully found, thoroughly seaworthy, and manned by a crew sufficient in number and experience who are physically fit to face bad weather. The owner/competitor/charterer must be satisfied as to the soundness of the hull, spars, rigging, sails and all equipment. He must ensure that all safety equipment is properly maintained, stowed and in date and that the crew know where it is kept and how it is to be used.

I agree to be bound by the rules that govern the event. In particular, **I have read the above and agree** to its provisions and that my boat conforms to its requirements.

I understand and agree that the information on this form will be maintained on the Organising Authority computers. This information may be shared with partner organisations directly involved with and for the purposes only of running the event.
